- 2. <u>ALL ORDERS OF \$125,000.00 OR MORE</u>. All orders of \$125,000.00 or more are subject to special terms and conditions to be identified and specified by Seller during the formal quote process, which terms and conditions must be accepted and agreed to in writing by Buyer prior to Seller's acceptance of any such order.
- 3. **SEVERABILITY**. The invalidity, in whole or in part, of any provision of this Rider shall not affect the validity or enforceability of any other provision herein.
- 4. <u>HEADINGS</u>. The headings in this Rider are included for convenience only and shall neither affect the construction or interpretation of any provision in this Rider nor affect any of the rights or obligations of the parties to any sales contract of which this Rider is made a part.
- 5. <u>AMBIGUITIES</u>. Any rule of construction to the effect that ambiguities are to be resolved against the drafting party shall not apply in interpreting any sales contract of which this Rider is made a part.
